# Fund Facts RP Alternative Global Bond Fund – Class F-USD

May 30, 2019

This document contains key information you should know about Class F-USD of RP Alternative Global Bond Fund (the “Fund”). You can find more detailed information in the Fund’s simplified prospectus. **Before you invest in any fund, consider how the fund would work with your other investments and your tolerance for risk.**

**This mutual fund is an alternative mutual fund. It is permitted to invest in asset classes or use investment strategies that are not permitted for other types of mutual funds. The specific strategies that differentiate this Fund from other types of mutual funds include the use of derivatives for hedging and non-hedging purposes, the increased ability to sell securities short, and the ability to borrow cash for investment purposes. While these strategies will be used in accordance with the Fund’s investment objectives and strategies, during certain market conditions, they may accelerate the pace at which your investment decreases in value.**

**Distributions:** The Fund distributes any net income on or about each calendar quarter end (March, June, September and December) and any net capital gains annually in December. All distributions paid will be automatically reinvested in additional units unless otherwise elected by you in writing.

**Minimum Investments:** US\$1,000 initial, US\$100 additional (*minimum investment amount may be waived by the Manager*)

### What does the fund invest in?

The investment objective of the Fund is to generate attractive risk-adjusted returns with an emphasis on capital preservation. The Fund will invest primarily in investment grade debt and debt-like securities of corporations and financial institutions.

The Fund may also use derivatives, engage in short selling and borrow cash, which may introduce leverage into the Fund. The Fund’s maximum aggregate exposure to short selling, cash borrowing and derivatives used for leverage must not exceed 300% of the Fund’s net asset value, calculated on a daily basis.

### How risky is it?

The value of the Fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

### Risk rating

The Manager has rated this Fund's risk as **low to medium**.

Because this is a new fund, the risk rating is only an estimate by the Manager. This rating is based on how much the Fund's returns have changed from year to year. It doesn't tell you how volatile the Fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

#### No guarantees

Like most mutual funds, this Fund doesn't have any guarantees. You may not get back the amount of money you invest.

### How has the fund performed?

This section tells you how Class F-USD units of the Fund have performed since the Fund was created. Returns are after expenses have been deducted. These expenses reduce the Fund's returns.

### Who is this fund for?

This Fund may be right for you if:

- you want your investment to be hedged to the U.S. dollar;
- you plan to hold your investment for the medium to long term;
- you want to gain exposure to primarily investment grade debt securities of global issuers by employing alternative investment strategies to diversify the fixed income portion of your portfolio; and

### A word about tax

In general, you will have to pay tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the Fund in a registered plan such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

### How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell Class F-USD units of the Fund. The fees and expenses – including any commissions – can vary among classes of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

#### 1. Sales Charges:

There are no sales charges for the purchase of Class F-USD units of the Fund.

#### 2. Fund Expenses:

You don't pay these expenses directly. They affect you because they reduce the Fund's returns. The Fund's expenses are made up of the management fee, the performance fee, operating costs and trading costs. The annual management fee is 0.90% of the Class F-USD units' net asset value. Because this Fund is new, its operating expenses and trading costs are not yet available. The Manager will be responsible for operating costs of the Fund, other than certain fund costs that are payable directly by the Fund, in exchange for the payment by the Fund of a fixed rate administration fee of 0.25% per annum.

#### Performance Fee

The Fund pays the Manager a performance fee based on the total return, after expenses, of Class F-USD of the Fund during each calendar quarter. It is equal to 10% of the amount by which the total return of Class F-USD of the Fund during the calendar quarter exceeds the "high water mark" in which a performance fee has been previously paid for the class.

#### More about the trailing commission

There is no trailing commission payable to your representative's firm for Class F-USD units of the Fund.

#### 3. Other Fees: You may have to pay other fees when you buy, hold, sell or switch Class F-USD units of the Fund.

Fee	What you pay
<b>Short-term Trading Fee</b>	A fee of 2% of the amount redeemed may be charged if you redeem units within 30 days of purchasing such units. This fee goes to the Fund.
<b>Switch Fee</b>	You may have to pay a switch fee of up to 2% based on the net asset value of the applicable class of units of the Fund being reclassified when you reclassify between classes of the Fund. You may also have to pay a fee to your representative or representative's firm when you switch units of the Fund for units of another mutual fund. You may negotiate the amount with your representative. Fees charged by your representative's firm for switches and reclassifications are paid by redeeming units held by you.
<b>Class F-USD Fee-for-service</b>	Class F-USD units are available to you if you have a fee-based or wrap account for which you pay a fee directly to your representative's firm.

### What if I Change My Mind?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual fund units within two business days after you receive the simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
